

TERMS & CONDITIONS OF ENTRY

BIG BROTHER VIP COMPETITION

1. Instructions on how to enter and prizes form part of these Conditions of Entry. The competition is open to all residents Australia aged 18 years and over. Employees of the Promoter and their immediate families and agencies associated with this promotion are ineligible to enter.
 2. Entry is open to all VIP Members of the Big Brother website www.bigbrother.com.au who subscribe to either a Fortnightly or Season Pass throughout the promotion period. Entry into the draw is automatic and registered members may only enter once. Fraudulent memberships/entries will not be accepted and will be deemed invalid.
 3. The competition will be advertised on Network TEN. These competition Terms and Conditions apply in conjunction with the Big Brother and Ten Membership rules.
 4. To register, entrants will be required to provide various personal details including full name, email address, residential address, contact phone number/s, date of birth, valid credit card and gender for the purpose of verifying eligibility. Any contact details entered incorrectly shall invalidate the entry. Incomplete or incomprehensible entries will be deemed invalid and disregarded.
 5. Competition period commence on Friday 18th April 2008 @ 00:01 and concludes on Sunday 6th July @ 23:59 AEST.
 6. The draw for the major winner x 1 will take place at 10:00 EST on Monday 7th July 2008. The major prize is only available to Season VIP Members.
 7. The draw for weekly winners will take place each Monday (commencing Monday 28th April 2008 with the final draw being conducted on Monday 7th July 2008). 16. The Promoter reserves the right to refuse to allow a winner to take part in any or all aspects of the prize, if the Promoter determines, in their absolute discretion, that a winner is not in the mental or physical condition necessary to be able to safely participate in the prize. It is a condition of accepting the prize that the winner may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.

17. If for any reason any element of the prize/s becomes unavailable for any reason, which is out of the promoters control then a similar prize to equal value, will be awarded in lieu. In the event that for any reason whatsoever a winner does not take an element of the prize at the time stipulated by the Promoter then that element of the prize will be forfeited by the winner and cash will not be awarded in lieu of that element of the prize.

18. The Promoter and its associated agencies and companies shall not be liable for any loss (including, without limitation, indirect or consequential loss), expenses, damage, personal injury or death which is suffered or sustained (including but not limited to that arising from any person's negligence) in connection with using any prize, except any liability that cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

19. If for any reason this promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any

other causes beyond the control of the promoter, which corrupt or affect the administration security, fairness or integrity or proper conduct of this promotion, the promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the competition, subject to any direction given under the Lottery and Gaming Regulation 1993 (SA), and state permit regulation.

The Promoter reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for tampering with the entry process or for submitting an entry which is not in accordance with these Conditions of Entry, or if the entrant is engaged in any unlawful or other improper misconduct calculated to jeopardize the fair and proper conduct of the promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

The use of any automated entry software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid. Caution: any attempt to cause malicious damage or interference with the normal functioning of the SMS applications, the Promoter's website or the information on the website, or to otherwise undermine the legitimate operation of this promotion may be a violation of criminal and civil laws and should such an attempt be made, whether successful or not, the Promoter reserves the right to seek damages to the fullest extent permitted by law.
